
The Community Paramedic





The Remote/Isolated Community Paramedic






Historical Context

- Lobbying federal government (Health Canada becomes ISC)
- Need identified = Federal response = Position
- Indigenous access to appropriate "in community" care is not adequate
- 30% Nurse, Nurse Practitioner and Physician vacancy rate
- 36% Home and Community Care vacancy rate
- Traditional service model no longer meeting needs
- Alternative models of care needed based on unique community needs






Role of Paramedic Portfolio Manager


- Advise Minister's office on policy, programming, education, and development recommendations
- Developmental schemes
- Engage local stakeholders (tribal councils, politicians, health directors, elders, etc)
- Engage Pan-Provincial and Territorial stakeholder (Paramedic associations, Paramedic Chiefs of Canada, Public Safety Canada, etc)

- Execution strategy (provincial versus federal body)
- Community needs assessments with exploration of models of care
- Process mapping around development schemes
- Transport development
- Develop program scope, objectives, and targets
- CSA Health in North Community Paramedic Standard Tuktoyaktuk NWT
- Align Round Lake Mattawapit Coroners recommendations



Community Paramedics in the North Definitions

- Community Paramedics are a versatile health care provider who focus on 'in community' primary care and prevention.
- Services span the continuum of care including such activities as health promotion and education, injury prevention and life skills development, harm reduction, emergency response, resuscitation, and palliative care.
- Skilled at community engagement, developing community capacity through active case finding, the identification of gaps, and working with existing resources to implement solutions.
- Ability to provide services in differing environmental contexts from in-home, in-clinic, in-hospital, and multiple varying austere environments.



Goals in Community

- · Increasing community member's access to care,
- Decreasing emergent treatment and hospitalizations,
- · Increasing client sense of safety and wellbeing,
- Providing treatment in-situ,
- Reducing admissions to long-term care facilities.
- Honouring palliative patients cultural and traditional wishes in home/community




Ontario Current Status

 - Northern College





Ontario Next Steps

- Continue engagement and education of partners regarding the role of Community Advanced Care Community Paramedics in community care. Nishnawbe Aski Nation Transition Team is tentatively scheduled for early June 2019.
- Face-to-Face discussion with Paramedicine subject matter experts, community leaders, partners, and educators has been submitted and tentatively scheduled for the Fall 2019.
- Renewal of Interchange Canada Agreement to continue the work of the Paramedic Portfolio Manager.
- Salary parity to nursing occupation
- Resourcing communities for multi-year Community Paramedic development schemes is critical to success.
